- Silo costs are not transferable. All rates exclude VAT, except weighing costs, which include VAT.

#### NOTE:

- If concessions are made regarding the imposition of drying costs for wet grain, the applicable rate shall apply as if no concession is in effect.
- Drying will only occur if the relevant silo has enough space to accommodate the wet grain.
- OVK reserves the right to continuously adjust drying cost rates based on fluctuations in fuel prices and other relevant expenses.
- Wet wheat with a moisture content, for example, of 14.5% by weight is adjusted to 13% moisture, and the corresponding drying costs are levied.
- Shipments transported by rail and left on rail for longer than two weeks (14 days) may not hold OVK GRAAN responsible for claims resulting from insect infestation.

- OVK accepts no responsibility for the grading result after the load has left the OVK premises.
- Grading will only be done in season if capacity permits.

## WEIGHING COST (PRICES PER WEIGHING)
